Throughout 2017 AID/WATCH participated in existing networks and kept up the momentum on its campaigning as a counterpoint to the new 'aid paradigm' that is favouring national interest and private finance over the need for real aid.

2016 saw AID/WATCH focus internally to rebuild our organisational capacity. 2017, saw us become publicly active again. Aid/Watch has continued to build upon our research and advocacy efforts in monitoring and holding to account the aid-industrial complex that solidifies vulture capital, aid agencies, 'donor' governments and local cronies. This includes calling for a new aid agenda founded on global and climate justice to address the pressing problems of growing inequality and climate change.

In 2018, AID/WATCH will continue to expose bad aid, this will include critiquing Privatisation of Aid and developing a regional campaign against land-grabbing, focused on APEC 2018 to be held in Port Moresby in November.



Some of our work, initiatives, and projects in 2017 have included:



Coordination of a new Economic Justice
Network (EJN) - bringing together key
organisations working on global justice
including Union Aid Abroad-APHEDA, Jubilee
Australia, Australian Fair Trade & Investment
Network, SEARCH Foundation and the
International Campaign to Abolich Nuclear
Weapons. In April 2017, EJN held a public
event at NSW Parliament on 'Australian
Foreign Policy in the Age of Trump' to provide
an alternative voice in the debate on foreign
policy in Australia in light of Australia's
Australia's foreign policy White Paper.

#Justice4Paga - an initiative to expose illegal evictions in PNG with our partners Jubilee Australia, Human Rights Law Centre and *The Opposition* film. In seeking justice for the forcibly evicted Paga Hill community AID/WATCH's work has included research, lobbying, a petition, media, and public screenings of *The Opposition*.

There is nowhere more evident of the aid-industrial complex than in our work with the Paga Hill community in Port Moresby, Papua New Guinea. Evicted, displaced, abandoned - their homes were completely demolished at the hands of two Australian-run companies, Curtain Brothers and Paga Hill Development Company. What was once home to 3000 people of up to four generations, Paga Hill is now part of the Asia-Pacific Economic Co-operation (APEC) summit 'AELM Precinct' which will take place in November 2018.


AID/WATCH wrote to the Minister for Foreign Affairs on 28 February 2017, requesting detail on the Australian APEC assistance funding package - close to \$75m is committed, \$50m of this being 'development assistance', for a meeting of 20 Asia-Pacific government leaders, including President Trump. Off the back of the letter AID/WATCH launched a petition calling for Australia's public





money not to enrich land grabbers in PNG and that global summits should not be bankrolled by development aid. AID/WATCH believes this is a gross misuse of precious aid money.

AID/WATCH, in partnership with Paga Hill leaders, Jubilee Australia, Human Rights Law Centre and The Opposition film will continue to challenge the illegal eviction of the Paga Hill community and seek #Justice4Paga. AID/WATCH will continue to challenge the use of Australian aid in supporting the APEC Summit and conduct a wider research and advocacy initiative against land grabbing in PNG and the Pacific in the run-up to APEC in 2018.



Graun Na Gutpela Sindaum Long Papua Nuigini - 'Land is Life' campaign publication in Tok Pisin for PNG communities highlighting the need for economic alternatives for rural families maintaining their customary land as the basis for rich hybrid livelihoods.

The publication is a shortened and adapted version of Australian academic Tim Anderson's Land & Livelihoods in Papua New Guinea book. Translated in Tok Pisin for Papua New Guinean communities the booklet has been distributed and disseminated by PNG partner organisation, Bismarck Ramu Group to local PNG communities who are fighting developments and destruction of their ways of life, livelihoods, local economies, lands, and food sovereignty. The purpose of the publication is to support rural PNG communities with alternative economic options by maintaining customary land as the basis for rich hybrid livelihoods.

Submissions and Proposals: AID/WATCH Submissions and Proposals in 2017 included:

- Submission to the DFAT White Paper for Australian Foreign Policy and Joint Standing Committee on Electoral Matters;
- Proposals for amendments to the Commonwealth Electoral Act 1918 has seen our landmark 2010 Aid/Watch case being sighted several times in the media.




